

“Sledge Hammer Pulling” Sled Rental Agreement

1. The person who transports the sled, the sled operator, and helpers receives free admission with no charge for gate fees.
2. Sled owner(s) shall not be held responsible in any way for injuries to any puller, spectator and or damage(s) or breakage of parts to any pulling vehicle.
3. For safety reasons and for clear visibility of pulling vehicles to the sled operator, the sled will not be operated under severe dusty track conditions. Therefore, the track must be watered down to prevent dust before and if needed, during the pull (between classes).
4. The sled, weighing scales and measuring device will be provided by Sledge hammer pulling at the pull site(s), Help will be provided by the pull site crew or pullers to set up and load all equipment before and after the pull.
5. The pull site crew shall provide the necessary equipment (blade-off tractor, footage markers, out of bounds striping, and Announcer) and the crew to operate the equipment to keep the track conditions properly maintained. Pull site crew shall flag the pulling vehicles, hook/unhook the pulling vehicles.
6. All pulling vehicles must have at least a 1-½” hole, opening for the hook.
7. For safety reasons, all pulling vehicles must have wheelie bars.
8. The spectators shall remain at a safe distance a minimum of 15 feet from the track, with a barrier positioned no less than 10 feet from the boundary lines on either side of the track.

SPONSOR'S CHECKLIST FOR SPONSORING A GARDEN TRACTOR PULL

1. ____ Preparation of track & pit areas:
 - * Track surface and subsurface
 - * Pit area should be large enough for up to 75 tractors
 - * Smooth level area for placing of the scales.
 - * Parking area for trucks & trailers
 - * Spectator area
 - * A water tank or truck and the ability to evenly spread water on the track.
 - * The Prepared track should be a minimum of 20' wide.
2. ____ Confirm pull date with sled operator(s) to ensure availability of sled(s) and scales
3. ____ Equipment to work track and maintain the track during the pull.
4. ____ Personnel to operate equipment before, during and after the pull.
5. ____ Trophies/Plaques/Benefits (if awarded)
6. ____ The sponsor will be the only person to cancel or reschedule a pull.
7. ____ Notify and provide the club secretary with the information for a flyer to send out to club members approximately two weeks in advance of scheduled pull date.
8. ____ Any class change decisions will be made by the club officers, the sponsor and the club members in attendance.
